

Cranbrook State School - 2025 Bus Service Information

Cranbrook State School operates its own private bus service for use by students travelling to and from school and for other school related activities such as excursions. **The collection of students will be from their residence or other parent allocated collection point.**

The School adheres to the Queensland Government **Code of Conduct for School Students Travelling on Buses** as well as incorporating our own policies and procedures in relation to the use of its private bus service. It is School policy that seatbelts must be worn at all times. This is in compliance with Queensland Transport legislated requirements.

The ongoing provision of the bus service is dependent on sufficient patronage and the School reserves the right to discontinue the service if it is not adequately supported.

Fees are charged for full terms only and no pro-rata rates are available.

There will be 1 bus service in the morning and afternoon:

Service 1: Collections from 7:30am to 8:50am
Drop off from 3:00pm to 4:00pm- 30 available seats

It is likely that demand for places on the buses will be greater than the capacity of them and the submission of this Application Form does not guarantee a seat on the bus. Seats will be allocated on the receipt of application and preference given to those students who wish to utilise the service on a daily basis. Please contact the bus driver directly if your child is absent. No alternative collection or drop off points can be made.

Activity risks and insurance

The Department of Education does not have personal accident insurance cover for children/students. If a child/student is injured as a result of an accident or incident while participating in the activity, all costs associated with the injury, including medical costs are the responsibility of the parent/carer. Some incidental medical costs may be covered by Medicare. If the parent/carer has private health insurance, some costs may also be covered by your provider. Any other costs must be covered by the parent/carer. It is up to the parent/carer to decide the type/s and level of private insurance they wish to arrange to cover their child. Please take this into consideration in deciding whether or not to allow the child/student to participate in this activity.

- 3. I/we understand that my child may be refused permission to travel if bus collection fees are not paid prior to collection.
- 4. I/we understand that if my child does not comply with the Code of Conduct for School Students Travelling on Buses, and the conditions of use stated in the enclosed form, they may not be permitted to travel on the school bus for other events.
- 5. I/we understand that the collection and drop of destination for my child advised, will be the only collection and drop off point that he/she will be collected/dropped at, unless notified by phone call to Amanda as agreed to as a reasonable point of collection/drop off.
- 6. I/we understand that if we don't inform the Bus drivers that our student/s are not travelling on the bus, we will not be entitled to a refund.
- 7. I/we understand that if the Student Resource Scheme fees aren't up to date, our students' bus service may be cancelled.
- 8. I/we have read all of the information contained in this form in relation to the activity (including any attached material)
- 9. I am aware and acknowledge that the department does not have personal accident insurance cover for students.
- 10. I/we understand that in the event of accident or illness, school staff may obtain or administer any medical assistance or treatment the child/student may reasonably require, including contacting their doctor.
- 11. I/we accept liability for all reasonable costs incurred by the department in obtaining such medical assistance or treatment (including any transportation costs) and undertake to reimburse the department the full amount of those costs.
- 12. The Cranbrook School Bus Service will operate from Monday the 28th January 2025 until Wednesday the 10th December 2025. Limited services will be available Thursday 11th December and Friday 12th December 2025.
